

## **MENTAL HEALTH FOUNDATION OF NEW ZEALAND GENERAL CONDITIONS OF ENTRY AND COMPETITION RULES**

1. These Conditions of Entry and Competition Rules apply to all promotions run by the Mental Health Foundation of New Zealand (MHF). MHF will conduct the promotion.
2. Entry into the promotion is deemed acceptance of these Conditions of Entry and Competition Rules. MHF reserves the right to exclude any person from the contest on the grounds of criminal record, or for medical reasons.
3. Prizewinner(s) will be determined by random draw (unless otherwise specified). Prizewinner(s) will be notified by MHF by phone and or mail.
4. Prizewinner(s) of the Photo a Day competition will be chosen by a judging panel appointed by the daily prize donor and the MHF.
5. Entries to the Photo a Day competition must be posted on the day of each daily competition.
